## **Application for “Recorded Stock” 2018**

Only members of the Society can enter sheep into the VBSS database.

This form is to be completed and signed by the breeder of the offspring. If the offspring is to be transferred to a new owner simultaneously with the submission of this application for Recorded Stock, please use the Transfer Form. A Bill of Sale is also highly recommended outlining the terms of the sale agreement and it is requested that some proof of agreement be submitted with the Transfer Form. A sample document is provided by the VBSS for member use, if needed.

The Application for Recorded Stock is designed to provide all information necessary for the entry of new animals into the database. As of 2018 there is the singular option for entry into the database as Recorded Stock as there is only Valais Blacknose semen available for the program and all animals born will be F-1s or (50%) blood.

For all 2018 submissions it will be necessary to complete a Foundation Ewe application for each ewe producing the F-1 offspring listed above.

As all offspring submitted will be the progeny of AI, it is also necessary to submit a completed Certificate of Service with this Application. The stated requirement that the Certificate be filled out at the time of service is waived for 2018. The Valais Blacknose sire, foundation ewe, and date of service are of primary importance this year. Thereafter, the form will need to be used at the time of service and signed by the AI technician performing the procedure, or the owner of the ram depending on the circumstance.

By signing and submitting this form, the breeder is certifying that the information is correct and can be verified by breeding records retained by the breeder.
